4a (Code:) (Expenses \$ 370,453. including grants of \$) (Revenue \$) Public Education: The Alliance added seven new members in 2016- bringing total membership for 2016 to 96. The Alliance continued implementation on its five-year strategic plan which focused on deeper member engagement, encouraging more member-led initiatives, and deliberate education and advocacy efforts. The Alliance hosted and/or participated in 37 events, which had a cumulative reach of over 2,700 individuals. The Alliance also continued to actively engage with ProMedica to educate healthcare providers of the connections between hunger and poor health, including regional conferences in New York, NY (April 2016) and Loma Linda, CA (September 2016). The Alliance strengthened our diverse, member-led Advocacy Committee, focusing on messaging the issue of hunger across a variety of platforms

4b (Code:) (Expenses \$ 585,611. including grants of \$) (Revenue \$) Hunger-Free Communities: In 2016, the Alliance Hunger-Free Communities Initiative continued to connect over 70 local anti-hunger communities around the United States. We maintained our online portal, [www.hungerfreecommunities.org] the Hunger-Free Communities Network, for coalitions, campaigns and collaborations committed to ending hunger in their localities to learn from each other and share their knowledge and experience with other hunger free organizers. The Alliance hosted its annual HFC Network Summit in Indianapolis, IN, in October 2016. The Alliance continued to promote its Advocacy Playbook.

4c (Code:) (Expenses \$ 1,081,229. including grants of \$ 572,903.) (Revenue \$) National Alliance Partnerships: In 2016 the Alliance to End Hunger continued its work through the National Alliance Partnership Program, made possible by a grant from USAID. The Alliance partnered with existing or nascent Alliances in six developing countries (Tanzania, Uganda, Ghana, Zambia, Malawi and Guatemala) to conduct capacity assessments, develop strategic plans, and provide technical assistance to help them build their organizational and financial capacity; diversify their coalitions, with emphasis on engaging farmers and other food producers; and increase their capacity for advocacy and policy analysis in the areas of agriculture, food security and nutrition. The Alliance also convened a meeting in Des Moines, Iowa and Washington, DC, of all six country alliance representatives for shared learning and

If the committee believes the conflict is real, the board member is asked either to resign from the board of directors or stop the activity that is creating the conflict. For 2015, there was an administrative oversight and this process was not followed during the year. However, subsequent to year end, the Alliance contacted its officers, directors, and key employees about any conflicts of interest in 2015. None were identified.

A more thorough market analysis of compensation of specific positions is provided by an outside compensation consultant on an ad hoc basis. The President's salary is reviewed by the board of directors of BREAD on a periodic basis. This is discussed and documented in the executive session. These notes are kept by the board secretary and are not open to the public. However, the board of directors does seek the same independent comparison data for the President that BREAD seeks for all other staff (including other members of the executive team).
