4a (Code:) (Expenses \$ 428,441. including grants of \$) (Revenue \$ 0.) Public Education: The Alliance added seven new members in 2018- bringing total membership for 2018 to 96. The Alliance continues to focus on helping its members have greater impact in their own anti-hunger efforts through education and events. The Alliance hosted and/or participated in 36 events, which had a cumulative reach of over 1,800 individuals. The Alliance strengthened our diverse, member-led Advocacy Committee, focusing on messaging the issue of hunger across a variety of platforms (agriculture, domestic and international health, and national security/defense) as well as on the importance of reauthorization of the global food security act and a strong Farm Bill. The Alliance continued its Youth Engagement Initiative including its youth advisory program and youth working group to connect young people

4b (Code:) (Expenses \$ 147,258. including grants of \$) (Revenue \$ 0.) Hunger-Free Communities: In 2018, the Alliance Hunger-Free Communities Initiative continued to connect over 78 local anti-hunger communities around the United States. We maintained our online portal, [www.hungerfreecommunities.org] the Hunger-Free Communities Network, for coalitions, campaigns and collaborations committed to ending hunger in their localities to learn from each other and share their knowledge and experience with other hunger free organizers. The Alliance hosted its annual HFC Network Summit in Minneapolis, MN, in October 2018 in partnership with Hunger Solutions Minnesota. The Alliance launched a capacity assessment and building tool for the HFC network. The Alliance is hosting 10 VISTAs placed across eight HFC sites to assist with backbone support and capacity building.

SDG2 Advocacy Hub: In August 2018 the Alliance to End Hunger assumed hosting responsibilities for the SDG2 Advocacy Hub from the World Food Programme. The Hub secretariat provides a centralized platform for communication and coordination around civil society engagement related to SDG2 - Zero Hunger.

A more thorough market analysis of compensation of specific positions is provided by an outside compensation consultant on an ad hoc basis. The President's salary is reviewed by the board of directors of BREAD on a periodic basis. This is discussed and documented in the executive session. These notes are kept by the board secretary and are not open to the public. However, the board of directors does seek the same independent comparison data for the President that BREAD seeks for all other staff (including other members of the executive team).
