The Alliance continues to focus on helping its members have greater impact in their own anti-hunger efforts through education and events. The Alliance hosted hosted/cohosted or meaningfully participated in 33 events throughout 2019 with a cumulative reach of 2,680 individuals. The Alliance strengthened our diverse, member-led Advocacy Committee, focusing on messaging the issue of hunger across a variety of platforms (agriculture, domestic and international health, and national security/defense) as well as working to build support for a select committee on hunger. The Alliance continued its Youth Engagement Initiative including its youth advisory program and youth working group

4b (Code:) (Expenses \$ 106,680. including grants of \$) (Revenue \$) Hunger-Free Communities: In 2019, the Alliance worked with 78 Hunger Free Communities (HFCs) that are part of our national Hunger Free Communities Network (including two new sites in New York City and Easton, PA). In addition to regularly engaging this critical network through training webinars and with our Self-Assessment Workbook tool (SAW)-a capacity assessment and building tool to help communities measure impact-this past November we hosted our annual HFC Summit in Washington DC, which engaged over 150 guests during a two-day conference of comprehensive planning and networking. We also recently launched the third year of our AmeriCorps VISTA grant project and are currently training 13 new VISTA leaders in 10 communities across the United States to engage volunteers and help address hunger within their

The Hub secretariat provides a centralized platform for communication and coordination around civil society engagement related to SDG2 - Zero Hunger. The Hub has now developed a robust policy framework and is building a narrative to support key global opportunities for SDG2 throughout 2020.

Any possible conflicts listed are reviewed by the Executive Director to determine if they truly reflect a conflict. If so, the statements are discussed with the Executive committee. If the committee believes the conflict is real, the board member is asked either to resign from the board of directors or stop the activity that is creating the conflict.

ATEH does not directly hire or compensate employees. All employees are employees of BREAD For The World, Inc. (BREAD), an organization exempt under section 501(c)(4). Periodically, BREAD's human resources department receives general market data from an outside compensation consultant to determine if salaries are in line with organizations of similar mission and/or size. A more thorough market analysis of compensation of specific positions is provided by an outside compensation consultant on an ad hoc basis. The President's salary is reviewed by the board of directors of BREAD on a periodic basis. This is discussed and documented in the executive session. These notes are kept by the board secretary and are not open to the public. However, the board of directors does seek the same independent comparison data for the President that BREAD seeks for all other staff (including other members of the executive team).
