RE: SNAP Nutrition Education: A Vital Tool Making America Healthy Today

Dear Chairs, Ranking Members, and Committee Members:

On behalf of the nearly 400 undersigned organizations, the Association of SNAP Nutrition Education Administrators (ASNNA) is pleased to share information highlighting the critical role of the SNAP-Ed program in advancing national food security and nutrition goals. SNAP-Ed is a cost-effective strategy that complements SNAP – our nation’s cornerstone food and nutrition security program – by delivering nutrition education and health promotion interventions that empower families to make healthier choices. It represents a proven investment that improves the health and food security of low-income individuals and families, supports the agricultural economy, contributes to the reduction of long-term healthcare costs, and helps build more resilient communities nationwide. The organizations listed below are deeply engaged in SNAP-Ed implementation or partnership and bring direct experience with the program’s transformative impact at the local, state, and national levels.

SNAP-Ed is a highly effective, evidence-based program that helps individuals and families make more nutritious food choices, stretch limited food budgets, increase physical activity, and make healthy choices easier in the community. Lead agencies work in partnership with trusted community organizations—including schools, healthcare, food banks, community centers, faith-based groups, and food retailers—to bring science-based, practical, culturally responsive education directly to the places people live, work, learn, and gather and to improve connectedness within the food system by bridging the gaps between local agriculture and communities. The result is a ripple effect of healthier habits, stronger food systems, and empowered communities.

Across the country, SNAP-Ed is delivering measurable, meaningful results:

- In Arkansas, SNAP-Ed has led to significant behavior changes: in FY21, 88% of adult participants adopted better food resource management practices, and 58% increased their vegetable intake. Youth engagement is equally strong, with 84% of students intending to follow MyPlate guidance. Additionally, the state’s Double Up Food Bucks program has increased revenue for over 125 farmers by connecting SNAP participants directly with local produce.
- In Pennsylvania, students participating in school-based SNAP-Ed programs are trying and enjoying more fruits and vegetables thanks to school gardens, healthy food tastings, and hands-on nutrition lessons. Parents, too, are reporting improved understanding of food labels and nutrition basics, making better choices for their families.
- In Minnesota, SNAP-Ed has partnered with the White Earth Nation's Maternal Outreach and Mitigation Services (MOMS) Program to deliver culturally grounded nutrition education to mothers in recovery from substance use. Of the 75 women who participated in the first year, 95% reported improvements in their ability to prepare healthy meals.

SNAP-Ed programs in other states offer equally compelling results. Here are just a few:

- In Alabama, *Live Well, Alabama*, partnered with communities and used social marketing to make the healthy choice the easy choice in homes, schools, and communities.
- In Colorado, the University of Colorado and Nourish Colorado focus on early childhood education, school wellness, and signature agriculture programs.
- In Illinois, SNAP-Ed contracted for a multi-year evaluation that demonstrated significant Return on Investment.
- In Maine, SNAP-Ed works with community, state, tribal, and national partners to meet hunger, nutrition, and health goals.
- In Michigan, SNAP-Ed has contributed to reduced food insecurity and better nutrition among older adults in rural communities.
- In New York, store-based education and cultural food access initiatives have increased the relevance and impact of SNAP-Ed in diverse neighborhoods.
- In Oklahoma, SNAP-Ed works in schools, clinics, FDPIR sites, farmers markets, senior centers, youth camps and social marketing campaigns, often with sovereign tribal nations.
- In Texas, food bank partnerships have helped families pair nutrition education with healthier groceries and meals.
- In California, *CalFresh Healthy Living* is delivered through local health departments, the University of California, Catholic Charities, and Area Agencies on Aging.

- In Oregon, the SNAP-Ed social marketing campaign, Food Hero, is research-backed and delivered through multiple channels, designed to increase vegetable and fruit consumption and build food resource management skills.

SNAP-Ed is transparent and shares its results from all the states. The searchable SNAP-Ed Library ([SNAP-Ed Library](#)) shows over 700 locally developed interventions customized for the communities in which they were delivered. ASNNA’s website compiles recent state impact reports and infographics ([State Highlight Reports | ASNNA](#)).

SNAP-Ed is more than a program—it is a catalyst for change, connecting nutrition policy to real-world outcomes that improve lives every day. It bridges the gap between federal nutrition programs, U.S. agriculture, and chronic disease prevention, advancing the broader mission of making America healthy. Whether helping a child discover the joy of growing their own food, a senior to prepare balanced, nutritious meals, empowering families to choose fresh produce on a limited budget, helping children be more physically active by creating safer routes to walk or bike to school, or revitalizing the only grocery store in a rural town, SNAP-Ed plays a vital role in strengthening communities.

At a time when diet-related diseases impact millions of families, driving up healthcare costs and placing an unsustainable burden on our healthcare system and the U.S. taxpayer, SNAP-Ed stands out as one of the nation’s most strategic and effective tools to promote individual, family, and community health and economic resilience.

As Congress advances the next Farm Bill and considers funding priorities through the budget reconciliation process, understanding the role and impact of SNAP-Ed is critically important. SNAP-Ed delivers broad benefits: improving health outcomes, reducing hunger, saving public resources, supporting American farmers, and equipping communities with practical, integrated solutions to address today’s food and health challenges.
